



## **KUKA College – Arrangements and conditions for restricted operations**

The health of our training participants and our employees is our top priority. We take the current developments around the coronavirus very seriously and act in accordance with the regulations § 2 Z 1 of the COVID-19 Measures Act, BGBl. II No. 98/2020, 15.03.2020.

### **The following arrangements have been made to ensure safe training operations**

- No shaking hands
  
- A minimum distance of at least 1m is maintained during conversations. The number of participants is reduced in order to ensure this also in the lecture room or in the practice robot cells.
  
- The training course participants have access to the following premises at the KUKA location in Steyregg:
  - Areas exclusively for college participants:
    - KUKA College, Lecture room, Winder Garden, WC ground floor
  - Mutual use with restrictions
    - Dining area (College and employees eat separately)
  
- Which equipment is available to ensure your own health?
  - Hand disinfectant: for self-protection
  - The possibility of hand washing with soap is given
  - Surface disinfectant for cleaning the operating device, ....: for self and external protection
  - Mouth-nose masks: for external protection
  - Single use gloves: for self and external protection
  
- Which equipment is available to ensure your own health?

At the beginning of the training, the participants are instructed about the procedures in the training operation in order to follow the measures together.



## **Requirements for participants:**

- The participant has not been infected with COVID-19 in the last 4 weeks or is required to be quarantined by the authorities.
- The participants insure not having stayed in one of the risk areas of Europe or in the quarantined areas of Austria privately or professionally during the last 2 weeks.
- The participants insure not having had any contact with COVID patients or suspected cases in the last 2 weeks.
- There has been no contact with COVID patients or suspected cases of COVID in the last 2 weeks, neither in the direct private nor professional environment.

If the requirements for participations are not fulfilled, participation is not possible under any circumstances. However, we offer online trainings for the first time or ask for participation at a later point.

If the participants disregard the measures of the regulation § 2 No. 1 of the COVID-19 Measures Act, BGBl. II No. 98/2020, 10.03.2020, the training course will be discontinued.

## **Do you need overnight accommodation?**

Our recommendation is the accommodation in the “Etagerie”, which is still open and does not require social contact at check-in and check-out.
