## Conditions of participation for the “Draw your dream robot” art competition

Participation in the “Draw your dream robot” art competition is free of charge and is governed exclusively by these conditions of participation. Participation is voluntary. The organizer is KUKA Aktiengesellschaft, Zugspitzstrasse 140, 86165 Augsburg, Germany.

### Art competition procedure

The duration of the art competition is from 15. October 2018 to 16 November 2018. During this time, pictures can be sent in by mail for participation in the art competition. The postage date determines eligibility.

### Participation

To participate in the art competition, the picture of the drawn “dream robot” must be sent via regular mail. Participation is only possible within the time period from 15. October 2018 to 16 November 2018. Entries sent after the closing date will not be taken into consideration when drawing the winners. Only one entry per participant is permitted for the art competition. Using multiple pictures to increase the chances of winning is prohibited.

Participation in the art competition is free of charge. Participation as well as the chances of winning do not depend on the purchase of goods or the use of services.

The pictures sent in will not be sent back to the participants.

### Eligible participants

Eligible participants are children who are not yet 15 years of age. Participation is only permitted with the consent of the legal representatives. A corresponding declaration of consent from the legal representatives must be included with each picture sent in. This declaration can be downloaded at <https://kuka.com/erw2018> . Entries sent without a declaration of consent cannot be considered and cannot participate in the art competition.

KUKA AG reserves the right to exclude persons from participation as it sees fit for legitimate reasons, for example in the event of

- (a) manipulation in connection with access to or conduct of the art competition,
- (b) violation of these conditions of participation or
- (c) false or misleading statements in connection with participation in the art competition.

### Prize, notification and awarding of the prize

Eligible winners are natural persons who are not yet 15 years of age.

The winners will be drawn randomly from among all the participants and promptly notified by e-mail. If the winner does not respond within a period of four weeks following notification, the drawing shall be repeated to substitute for the unredeemed prize entitlement, thus completely eliminating any prize entitlement of the original winner. If the prize has not been claimed after the draw has been repeated twice, the prize will be forfeited.



**The following prizes will be awarded:**

Prizes will only be awarded to the winners or their legal representatives (in person or by mail). An exchange or cash payment in lieu of the prize is not possible. The entitlement to a prize can be neither assigned nor transferred to a third party.

KUKA AG shall assume any costs that may be incurred for delivery of the prizes. Additional costs incurred by accepting the prize shall be the responsibility of the winner. KUKA AG shall also assume and settle any tax that may be due for the prize.

**Contact and jurisdiction**

Questions or objections in connection with the art competition must be addressed to KUKA AG. The art competition by KUKA AG shall be governed exclusively by the laws of the Federal Republic of Germany. For consumers, this choice of law applies only insofar as the protection granted is not withdrawn by mandatory provisions of the law of the country in which the consumer has their habitual place of residence.
