## Conditions of participation in the painting competition "Paint your get-well-robot"

Participation in the painting competition "**Paint your get-well-robot**" is free of charge and is governed exclusively by these conditions of participation. Participation is voluntary.

### Procedure of the painting competition

The duration of the painting competition is from 09.11.2020 - 30.11.2020. Within this period children can send in the picture of a painted robot by e-mail from their parent or guardian to [erw@kuka.com](mailto:erw@kuka.com) or by post and participate in the painting competition.

### Participation

To participate in the painting competition, the picture of the painted robot must be sent by e-mail from a parent or guardian or by post. The participation is only possible within the participation period 09.11.2020 - 30.11.2020. Entries received after the closing date will not be considered in the draw. Only one submitted entry per participant will take part in the painting competition. It is prohibited to use more than one e-mail address to increase the chances of winning.

Participation in the painting competition is free of charge.

### Eligible participants

Eligible are children of kindergarten and school age (natural persons who have not yet reached the age of 15). Minors require the consent of their legal guardians to participate. By participating, the participant confirms that this consent has been obtained.

KUKA AG reserves the right to exclude persons from participation at its own discretion if there are justified reasons, for example

- (a) in case of manipulations in connection with access to or execution of the craft competition,
- (b) in case of violations of these conditions of participation or
- (c) in the event of false or misleading information in connection with participation in the painting competition.



### Winning, notification and transmission of the prize

All natural persons who have not yet reached the age of 15 are entitled to participate in the profits. The winners will be drawn at random from all participants and will be informed promptly by e-mail about the prize. If the winner does not respond within a period of 4 weeks after being informed, a repeat draw will be held for the unredeemed prize entitlement, whereby the prize entitlement of the original winner is completely cancelled. If the prize is not redeemed after the draw has been repeated twice, the prize will be forfeited.

#### **The following prizes will be raffled:**

10 x KUKA surprise package

5 x KUKA robot model

The prize will be handed over exclusively to the winner (in person or by post). In the case of winners with limited legal capacity, a written consent of the legal representative must also be submitted to the person responsible for the check. Exchange or cash payment of the prize is not possible. The claim to the prize may neither be assigned nor transferred to third parties.

Any costs incurred for shipping the prizes will be borne by KUKA AG. Any additional costs associated with claiming the prize will be borne by the winner. KUKA AG will also assume and pay any necessary taxes on the prize.

### Contact and applicable law

Questions or complaints in connection with the painting competition should be directed to KUKA AG. KUKA AG's handicraft competition is subject exclusively to the laws of the Federal Republic of Germany. Legal recourse is excluded.

### Severability clause

Should a provision of these conditions of participation be or become invalid in whole or in part, the validity of the remaining provisions of these conditions of participation shall not be affected. In place of the invalid provision, the legally permissible provision which comes closest to the meaning and purpose expressed in the invalid provision in economic terms shall apply. The same applies in the event of a gap in these conditions of participation.
